This **Model Account Agreement** ("AGREEMENT") is made between **Eazygirls4u Sandusky, Ohio**

A separate Model Account Agreement must be sent for each individual person appearing in the selected performer account!

**Age Certification:** I hereby certify that I am at least 18 years of age (21 in some areas, check with local laws to make sure), or age of majority in my legal jurisdiction (whichever is greater). My signature also certifies that I will NOT provide Eazygirls4u with false identification (including name and/or date of birth).

I also certify that all decisions related to the content of my performances are made at my own discretion, and that my performances do not violate the local community standard of obscenity in my area, and that my performances do not violate any other laws. I am completely responsible for my own actions as a consenting adult. I am aware of my criminal liability and I understand that I am being contracted as a third party vendor to act, and I am personally responsible for any taxes owed. I understand that I am not in any way an employee or independent contractor of Eazygirls4u. The agreement (including the Terms and Conditions of the websites owned by Eazygirls4u) between me and Eazygirls4u does NOT tell me what my lawful content or my services shall be, and Eazygirls4u does NOT otherwise exercise dominion or control over me.

I indemnify and hold Eazygirls4u harmless from all related liabilities. I hereby discharge all persons related to Eazygirls4u of any past, present or future liabilities.

I further represent that I have fully read and agree with the contents of this document prior to its execution. I have not been induced to sign the same other than by recited considerations, by any statement made by Eazygirls4u, its agents, employees, or anyone acting on their behalf. My signature below is certification that the identification that appears below is true and accurate. I also certify that I will not provide any defamatory, abusive, threatening, racially offensive, or illegal material as a Studiomanager. I understand that if Eazygirls4u suspects that I have provided forbidden content, my account(s) will be frozen immediately for further investigation and **I will face permanent termination, cancellation and forfeiture of all payments from Eazygirls4u.**

I also certify that I will not force anyone to work as a performer on websites owned and/or operated by Eazygirls4u and all performers under my Studio Account are working by their own will. I will not solicit or take part in anything related to escort services or prostitution. I will grant with my signature that all performer accounts created under my Studio Account will be provided with true and accurate legal documents. By signing this document I agree and allow Eazygirls4u to monitor, record and log all my online activities on Eazygirls4u owned websites (including chat, video, email) and Eazygirls4u may copyright use and reuse, publish, distribute, edit, excerpt, exhibit and otherwise exploit my name (real or fictional), likeness, persona, performance, voice, pictures, chat, video, audio, biological information and identification, and for use throughout the universe, in perpetuity, without limitation, including in connection with the advertising, exploitation and publicizing of Eazygirls4u and its affiliates. Eazygirls4u shall own, and I grant and assign to Eazygirls4u all rights, title and interest, of every kind and character in perpetuity throughout the universe in and to Eazygirls4u the results, content, and proceeds of my appearance(s) (including all such performances made to date) videos, audio, chat, dialogue, acts, and dances, all of which are works made for hire specially commissioned as part of an audiovisual work, including all copyrights, renewals and extensions of copyright and Eazygirls4u shall be deemed the author thereof for all purposes. Eazygirls4u may edit my appearance as they see fit (and I waive any and all moral rights that I have), and I understand that Eazygirls4u has no obligation to use my appearance(s). I agree that still pictures may be made from video or my photographs, without further payment to me in printed publications, digitally on the Internet or via CD, or any other media, without restrictions. Eazygirls4u shall also have the right, and I shall fully cooperate with Eazygirls4u to let Eazygirls4u produce, distribute and otherwise exploit video/audio performances, trailers and behind the scenes. or making of programs incorporating my appearance(s).

## **Eazygirls4u Video Chat Studio Manager rules:**

Make sure your entire studio models are known with the following Performer rules and act accordingly!

**The following rules must be followed by every Performer on Eazygirls4u.com  
Violation of the rules will lead to temporary or permanent removal of your account!!**

1. Do NOT give out any personal information about yourself or any other performer, including but not limited to emails, addresses, phone numbers, account numbers, online chat ID's etc
2. Do NOT solicit for escort, prostitution or personal contact with customers. That includes exchanging emails, addresses, phone numbers, online chat ID's (such as Yahoo, MSN, ICQ, Skype etc.). **You will be banned on the first incident.**
3. All people appearing on your cam must have all the legal documents on file at our office. This includes friends and lovers, nude or non-nude !
4. If you present any kind of pre-recorded video in the LIVE sections of the site or keep breaking the website rules, we will close your account immediately.
5. People under the age of 18 are strictly prohibited to appear on cam. This includes everybody regardless of what country you live in. You will be banned on the 1st occurrence.
6. Do NOT make derogatory statements about other performers or customers either in free chat or in the paid sections.
7. You CANNOT leave the camera unattended. If you have other things to do then you must log off.
8. No role playing depicting underage sex, rape, incest, blood is allowed. No animals on screen (including pets)! You will be banned on the 1st occurrence.
9. Eazygirls4u.com is a membership organization. You have NOT been hired to work here, nor are you being paid as an employee.
10. Showing overly explicit content (partially or fully nude body and/or body parts, for instance) are NOT allowed in "Eazy Room Free Chat". Please make sure to abide by this rule otherwise your account may be suspended and/or terminated. Please display such content in the private paid sections ONLY.



11. All performers on the website must be at least 18 years of age which should be proven by the age verification document with an attached ID (ID card or passport).
12. Promoting other websites or services is strictly forbidden and may result in account termination!
